### Event Report

#### Objectives of the event:

- To make the students learn about the practical issues related to the labour laws.
- To enhance the understanding of procedural framework of labour courts in Delhi NCR
- To have an interaction with the various dispute resolution bodies and stake holders.

#### Outcome of the industrial visit:

The students (77) of BALLB 8<sup>th</sup> Semester and (83) of BBALLB 8<sup>th</sup> Semester visited the Labour Court Ghaziabad on 13.04.2022. The Labour Court in Ghaziabad have the jurisdiction in labour issues of the workers with in the territorial limits of the District Ghaziabad and the neighboring areas. The students have a very fruitful interaction with the officials and the experienced labour lawyers. They have been informed about the future prospective of labour laws in India.

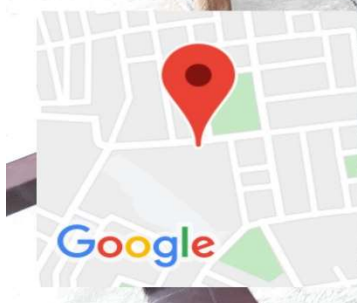
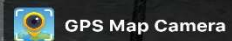

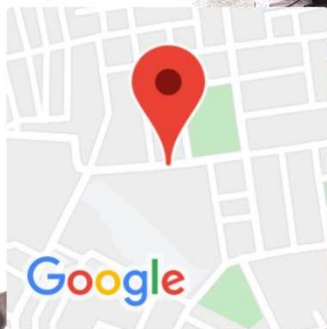
